### REQUEST FOR PROPOSAL N°2/2021 FOR THE DESIGNATION OF AN OPERATOR FOR THE MANAGEMENT OF THE EXPLOITATION OF THE GAMES OF THE MOROCCAN GAMES AND SPORTS

#### CORRECTIVE PROCUREMENT NOTICE

*The Marocaine des Jeux et des Sports informs the public that the above-mentioned request for proposal is the subject of this corrective procurement notice. Changes to the bidding documents are communicated to the competitors who have collected the bidding documents.*

#### **I. PURPOSE OF THE REQUEST FOR PROPOSAL**

The purpose of the request for proposal 2/2021 is to award to one or more economic operators or one or more consortia of economic operators, the contract(s) for the management of the operation of the games of the Marocaine des Jeux et des Sports, as from **1<sup>st</sup> January 2024** and this for an initial period of eight years, which can be extended by two additional years under certain conditions.

The request for proposal is divided into two lots. Lot 1 covers fixed odds sports betting and pari-mutuel betting (including betting on virtual competitions), except for betting on horse and greyhound racing. Lot 2 covers lotteries, instant sports lotteries (including electronic instant games) and raffles. Bidders may submit a proposal for one lot or for both lots. They may also be declared successful for both lots or for one lot only.

#### **III. CONDITIONS OF THE REQUEST FOR PROPOSAL**

##### **1. COLLECTION OF BIDDING DOCUMENTS**

By paying the sum of ten thousand dirhams (MAD 10 000.00) to be paid into the account of the MDJS, whose details will be provided upon request to the Bid Coordinator at AO-mdjs@mdjs.ma, the bidding documents can be collected from the procurement department, 1<sup>st</sup> floor, boulevard Rachidi in Casablanca. An electronic version can also be provided upon request of the competitor following payment of the above-mentioned sum.

##### **2. DOCUMENTS TO BE PROVIDED BY COMPETITORS**

The documents to be provided by the competitors must comply with the provisions of the procurement guidelines. The documents to be provided are those indicated in the bidding documents.

##### **3. SUBMISSION OF PROPOSALS**

Proposals must be submitted no later than **31 May 2022** before 10:00 am, which is the date and time of the proposals opening session:

- a personal hand-over with proof of receipt at the MDJS headquarters;
- to MDJS headquarters, by registered mail with proof of receipt or by express courier service; or
- during the proposal opening proceedings to the chairman of the bidding committee and before the opening of the proposals.

##### **4. PROPOSAL OPENING**

The opening of the proposals will take place in public on **31 May 2022** at 10 am at the MDJS headquarters located at 33 boulevard Rachidi in Casablanca.

##### **5. BID SECURITY**

The amount of the Bid Security shall be three million dirhams (MAD 3,000,000) regardless of the number of Lots for which the Bidder submits a Proposal.
